Section 11 Sterilization Room Protocols

Tax Exemption [Section 11] under Charitable or Religious Trusts and Institutions [Sections 11 to 13] : (i) Subject to the provisions of sections 60 to 63, the income of a religious or charitable trust or institution, to the extent specified in the Act, is exempt from tax when certain prescribed conditions are fulfilled.
